What Your Teen Needs to Succeed

Notes:

1. Welcome and Overview (5 minutes)

Before this session, download the Background Information: The Power of the Developmental Assets (1-LI-PT) and go through it carefully to understand the concept of the 40 Developmental Assets and why these 40 Developmental Assets are important for financial literacy.

Arrive early. Highly consider using the optional PowerPoint Presentation PDF and the optional Handout. Both will greatly enhance your sessions. If you're using the PowerPoint Presentation PDF, show the "Welcome to Bank It" slide as participants enter the room. Greet each participant individually and learn their names as they arrive. Have them create a name tag with their first name only.

Give participants a copy of the Bank It Notes #1-LI-PT and either a pen or pencil. Have them sit in clusters of about four people. If possible, have them sit at tables. Then welcome the whole group to the session.

Say: Welcome to Bank It. Bank It delivers real-world financial topics and tools for parents and teens that make it easier to understand, talk about, and manage your money. Bank It was developed by Capital One and Search Institute. I'm glad each one of you is here.

Today we will focus on what your teenager needs to succeed, and we plan on meeting three goals. One: By the end of this session, you will be able to identify what your teenager needs to succeed. Two: You will be able to recognize the 40 Developmental Assets. Three: You will be able to give examples of some of the 40 Developmental Assets.

Feel free to use your Bank It Notes to write what you learn as we go along. At the end of the session, we will take time to complete a short evaluation. (If this session is not the first session you're presenting to this group, consider briefly discussing the optional challenge that you may have given participants at the end of your previous session.)

2. Activity: Define Success for Teenagers (15 minutes)

Tell the group you're going to do an activity about teen success. Explain that participants will spend five minutes talking to about two or three people around them. First have them go around and say their first names. Then have them discuss how they would know if their teenager were successful.

After five minutes, ask: *How do you define a successful teenager?* Write people's ideas on a flip chart. Watch for examples that fit with the 40 Developmental Assets. Note that some parents will identify traits they don't want (such as not abusing alcohol, not having sex, etc.). Include these examples as well.

3. Present: Developmental Assets (15 minutes)

Explain that for our teenagers to live well, we need them not only to succeed by making positive money choices but also to succeed in all areas of life. Say: *Researchers at Search Institute have found that teenagers who are more likely to succeed in life have something called Developmental Assets.*¹

Who has ever heard of the 40 Developmental Assets? (Ask people to raise their hands. Acknowledge anyone who has her or his hand raised.) *The Developmental Assets are 40 common sense, positive experiences and qualities that help influence choices young people make. These 40 Developmental Assets help kids become caring, responsible, successful adults.*²

*More than three million teenagers have been surveyed across North America since 1989.*³ *Researchers found that kids with more Developmental Assets are more likely to succeed than those with fewer Developmental Assets.*⁴

Ask: *So if there are 40 Developmental Assets, how many do you want your teenager to have?* (Answer: A lot, 40.) *It's important to see why the 40 Developmental Assets help teenagers make positive money choices.*

*Researchers divide kids into four categories: Kids with 10 Developmental Assets or fewer. Kids with 11 to 20 Developmental Assets. Kids with 21 to 30 Developmental Assets, and Kids with 31 to 40 Developmental Assets.*⁵ Ask: *Which category do you want your teenager to be in?* (Answer: 31 to 40).

*For example, only 27 percent of kids who have 10 Developmental Assets or fewer save money.*⁶ *As kids get more Developmental Assets, the more likely they will save money. In fact, 72 percent of teenagers who have 31 to 40 Developmental Assets save money.*⁷

*Let's stalk a little about what some of the 40 Developmental Assets are. Developmental Asset #1 is family support.*⁸ *Developmental Asset #10 is safety.*⁹ *Developmental Asset #23 is homework.*¹⁰ *Developmental Asset #26 is caring.*¹¹ *Developmental Asset #29 is honesty.*¹² *Developmental Asset #38 is self-esteem.*¹³

Notes:

Ask: *Why would doing homework at school help your teenager make better money choices?* (Give participants time to respond.) Ask: *Why would being honest, which is Developmental Asset #29,¹⁴ help your teenager make better money choices?* (Give participants time to respond.)

There is a two-way street between Developmental Assets and money. Search Institute researchers say that when your teenager has a lot of the 40 Developmental Assets, your teenager is more likely to make positive money choices.¹⁵ If your teenager is making a lot of positive money choices, your teenager is more likely to have more of the 40 Developmental Assets.¹⁶

If you plan to distribute the optional handout, use it at this time.

4. Discuss (10 minutes)

Say: *Take some time to talk to the people near you. Talk to about two or three people. Take turns. I want you to do three things. 1. Say your first name. 2. Say why you want your teenager to succeed in life. 3. Say why you want your teenager to make positive money choices. Start with the person who woke up the earliest this morning. Then have each person take a turn.*

5. Review and Evaluate (10 minutes)

Review what was accomplished during this session. Ask: *What do teens need to succeed?* (Answer: the 40 Developmental Assets.)

Ask: *What are the Developmental Assets?* (Answer: 40 experiences that help teens become a caring, responsible adult.)

Ask: *How many Developmental Assets are there?* (Answer: 40.)

Ask: *What are some examples of these 40 Developmental Assets?* (Answers: Family support, safety, homework, caring, honesty, and self-esteem.)

Ask: *Why are Developmental Assets important?* (Answers: They help teenagers succeed. They help teenagers make positive money choices.)

Ask: *How can Developmental Assets lead your teenager to making positive money choices?* (Answer: They're connected. The more Developmental Assets your teenager has, the more positive money choices your teenager will make.)

The more positive money choices your teenager makes, the more Developmental Assets your teenager will have.)

At the end of the review, distribute Evaluation #1-LI-PT to each participant. Give participants time to fill out the evaluation. Collect all the evaluations after participants finish so you can find out the measurable outcomes for the session.

6. Close (5 minutes)

Have participants stand. Say the following statements and have participants repeat each one after you. Say: *I want my teenager to succeed.* (Repeat.) *I know my teenager can succeed.* (Repeat.) *My teenager can succeed with the 40 Developmental Assets.* (Repeat.) *My teenager can make positive money choices.* (Repeat.)

Challenge participants to talk to family members about this topic, which is listed under the Talk about It section of their Bank It Notes. Thank everyone for coming.

Optional Activities

1. Distribute Handout #1-LI-PT: What Teens Need to Succeed. Talk about the 40 Developmental Assets. Go through examples of the 40. Encourage participants to keep this list in their homes or at work.

2. Show the PowerPoint Presentation PDF #1-LI-PT. Use the presentation to accompany the one-hour session.

3. Give Participants a Challenge. Encourage participants to use the next week to get to know the 40 Developmental Assets better. Have them focus on one Developmental Asset per day. (If you wish, follow up during your next session to find out how the challenge went.)
